Subject: Proposal for providing additional time to complete the ongoing Awaas+ 2024 survey for identification of additional eligible rural households under the Pradhan Mantri Awaas Yojana- Gramin (PMAY-G) - regarding.

Sir,

I am directed to refer to the State Government's letter No. 2044/APSCL/E&P/ PMAY G 2.0/ Survey/2025 dated 13th October 2025 requesting for allowing Awaas+ 2024 household Survey in Gram Panchayats (GPs) under the UDA areas of the State and seeking additional time for completion of the Awaas+ 2024 household Survey under the PMAY-G in these areas.

2. In this regard, considering the request made by the State Government, the Competent Authority in the Department of Rural Development has decided to grant an additional time of 15 days from the date of issue of letter till **5th November 2025** to the State Government of Andhra Pradesh, to complete the Awaas+ 2024 household survey process and identify all the eligible households in all the districts of the State, including the Gram Panchayats in UDA areas. Further, the State Government is also requested to ensure that all the identified and surveyed households reside in the Rural areas of the State.

3. The State Government is also requested to identify all eligible rural households within this extended timeline and complete the survey using the Awaas+ 2024 Mobile Application of this Ministry. It is informed that all the modules of Awaas+ 2024 mobile application like verification, checker and deletion would run also on these additional households once the State marks these districts as survey complete or after closure of this window. **It may also be noted that no further extension in timeline would be granted by this Department.**
